ADIL ABDULALI

President and Chief Science Officer, MOV37/Protégé Partners

Adil has 26 years of experience in the markets. He received an M.A. in pure mathematics from MIT and B.A. in mathematics from University of Pennsylvania. He spent the first half of his career trading fixed income derivatives at JP Morgan, Nikko, Nomura, and Barclays. At Nomura and Barclays, he ran the systems and analytics groups for these products. He subsequently joined Capital Market Risk Advisors as a Senior Advisor specializing in structured products and hedge fund valuation. He joined Protégé in 2003 to head Risk Measurement. Adil became a partner in 2006 and specializes in Autonomous Learning Investment Strategies, Relative value and Market Independent Strategies. Adil used geometry to invent the Bias Ratio, a metric that detects return smoothing by active managers.

Salem Abraham, President, Abraham Trading Company, has been using quantitative models to trade global futures markets for over 25 years. Salem began trading while attending Notre Dame, where he graduated cum laude with a B.B.A. in Finance in 1987. In January of 1988, he began using his systematic approach to trade managed accounts. He registered as a Commodity Trading Advisor in October 1988 and organized Abraham Trading Company in 1990. Salem continues to lead the research efforts at Abraham Trading Company. Salem has been featured in Michael Covel's books The Complete Turtle Trader and Trend Following. He has also appeared in Bloomberg Markets, Absolute Return, Barron's, and the NY Times. Salem is registered with the Commodity Futures Trading Commission and is a member of the National Futures Association. He held full memberships at both the Chicago Board of Trade and the Chicago Mercantile Exchange. Salem resides with his family in Canadian, Texas. He is actively involved in improving education in Texas.

NATHANAËL BENZAKEN

Chief Executive Officer of Lyxor Inc.

Nathanaël Benzaken was appointed CEO of Lyxor Inc. in August 2014. Mr. Benzaken joined Lyxor S.A.S. in March 2001 as the Head of the Long/Short Equity Desk. He was promoted to Managing Director and Head of Hedge Fund Research and Selection in January 2005, where he was in charge of construction and management of the Managed Account Platform, including due diligence, selection, and risk management of hedge funds. Mr. Benzaken was appointed Head of the Managed Account Platform in June 2009. In July 2013, he was promoted to Deputy Head of Alternative Investments, and Head of Business Development for Managed Accounts. Prior to joining Lyxor S.A.S., Mr. Benzaken was a Manager of the Financial Risk Consulting Division at Andersen (Luxembourg) for two and half years and Treasurer at CréditAgricole for three years. Mr. Benzaken graduated from Kedge Business School (Marseille, France) and holds a master's degree in Finance and Computer Science from Toulouse University (France).

NANCY DAVIS

Managing Partner and Chief Investment Officer, Quadratic Capital Management LLC

Ms. Davis founded Quadratic Capital Management in 2013. She is Managing Partner and Chief Investment Officer of the firm. Ms. Davis began her career at Goldman Sachs where she spent ten years, the last seven at the proprietary trading group where she became Head of Credit, Derivatives and OTC Trading. Prior to starting Quadratic, she served as a portfolio manager at Highbridge where she managed \$500 million of capital in a derivatives-only portfolio. She later served in a senior executive role at AllianceBernstein. Ms. Davis writes and speaks frequently about financial topics and world markets. She has been published in Financial News, Absolute Return and Institutional Investor and has contributed papers to two books. She has been interviewed by The Economist, The Financial Times, New York Magazine and Le Figaro. Ms. Davis is a board member of the International Partners Committee and was a keynote speaker in China at the Asset Management Association's annual conference. Founder and Chief Investment Officer, Arctic Blue Capital

Jean-Jacques Duhot is the founder and Chief Investment Officer of Arctic Blue Capital, a systematic commodity strategy as well as a tail risk strategy using futures and ETF's designed to have a different exposure and low correlation to trend followers and traditional CTAs. Jean-Jacques first designed and ran the Arctic Blue strategy at the Caisse de Dépôtet Placement du Québec where he was Head of Tactical Global Macro. Jean -Jacques and his team then moved to CIBC in Toronto and New York where he was Global Head of Proprietary Trading, then joined Millennium and ran the Arctic Blue strategy successfully from the Millennium London offices. He set up Arctic Blue as a stand-alone hedge fund in 2014 to open the strategy to external investors. In July 2017, H2O become a majority shareholder of Arctic Blue Capital.

In this role from 1998 through 2005, he served the investment needs of major institutional investors across the U.S., including corporate, public, and Taft-Hartley pension plan sponsors. Lofton worked across multiple asset classes including Hedge Fund, Private Equity and Real Estate investments as well as long only equity and fixed income investments. Before 1998, Mr. Holder spent six years with JPMorgan Securities, Inc. as an investment banker and five years with The First Boston Corporation (currently Credit Suisse) in a similar role. Mr. Holder currently serves as a Trustee and Chair of the Investment Committee for the Edwin Gould Foundation for Children. Ernest L. Jaffarian is the Founder, and Chief Executive Officer and Chief Investment Officer of Efficient Capital Management, LLC. He is a veteran of over 25 years within the alternative investment industry in the areas of trading, portfolio construction, and risk management. In 1986 he joined Chicago Research & Trading Inc. (CRT) as a member of the proprietary trading group on the floor of the Chicago Board Options Exchange and rose to position of Senior Vice President for OTC Treasury Options. Immediately prior to founding Efficient, Jaffarian was responsible for the managed futures department of Hull Equity Management, LLC and for the allocation of Hull Trading Company, LLC's proprietary capital among trading advisors. Jaffarian is a CAIA® designee and the author of A Survey of the Managed Futures Industry (2007) and the chapter on Managed Futures in CAIA Level II: Advanced Core Topics in Alternative Investments (Wiley & Sons, 2009). Jaffarian is currently on the Board of Directors of the National Futures Association.

Grant Jaffarian is Crabel AlphaTerra LLC's President and Chief Investment Officer. Additionally, Jaffarian serves on Crabel Capital Management's Executive Committee and holds the title of Crabel Product Specialist. In his role at Crabel Capital, Jaffarian oversees all Crabel initiatives under the AlphaTerra brand. This includes Portfolio Management responsibilities, on-going research involvement, general strategic prioritization and overall oversight. Further, Jaffarian is active on the Crabel Executive team and as a representative for core Crabel products including the flagship Multi-Product. Prior to Crabel/AlphaTerra, Jaffarian spent approximately a decade with Efficient Capital Management, LLC as their Chief Investment Officer. While at Efficient Capital, Jaffarian allocated 2.9 billion USD at peak assets managing the portfolio construction, due diligence and manager selection processes. Before Efficient Capital, Jaffarian founded Petra Intraday, a high-frequency emerging manager.
