From there, Frank went to the US Securities and Exchange Commission, being appointed Senior Policy Advisor to the Chairman and Chief Spokesman for the Commission as well as a member of the SEC Senior Staff. He was also the Bank's first Chief Political Strategist. In this role he advised the Bank's top institutional clients globally on US and geopolitical issues.
